January Speaker: Ed Lorenzen, Senior Advisor at the Committee for a Responsible Federal Budget



The Panhandle Tiger Bay Club will be hosting Mr. Ed Lorenzen, Senior Advisor at the Committee for a Responsible Federal Budget as our January 2015 speaker. The meeting will be held at New World Landing on Friday, January 15th. Lunch is served at 11:30, the program begins at noon.

Mr. Lorenzen will be discussing the progress that has been made in reducing the deficit since the Simpson-Bowles report and the work that remains to be done.

Prior to joining the Committee staff, Ed served on the staff of the Commission on Fiscal Responsibility and Reform. He is a longtime veteran of the Congressional Budget process, having served as policy advisor and Legislative Director to former Congressman (and current Co-Chairman of the Committee board) Charlie Stenholm from 1990 through 2004 and as Senior Policy Advisor for House Majority Leader Steny Hoyer from 2007 through June of 2010. Ed received his bachelor's degree in government and international service from American University. Ed graduated from The American University in 1992 with a degree in government and international relations.

Mr. Christopher Farrell of Judicial Watch Gives Eye-Opening Presentation



Mr. Christopher Farrell of Judicial Watch, a conservative, non-partisan educational foundation that promotes transparency, accountability and integrity in government, politics and the law, was our December speaker. Judicial Watch investigates, litigates and sometimes sues the government to help bring our judicial system to justice. Being the Director of Investigations & Research, Mr. Farrell gave an eye-opening presentation about many cases in the past and present.

One of his main points of discussion was Hillary Clinton's involvement in the Benghazi attack and her use of a private email server. He stated that Hillary Clinton is the only government official in history to deliberately use a private and unsecured server to transact governmental business. Mr. Farrell said that they do have legal findings that she had top secret intelligence that went across her private server and there is also evidence that it was absolutely compromised and hit by an outside intelligence agency. Mrs. Clinton was emailed, along with the leadership of the State Department about the Benghazi attack. They were notified again 3 hours into the attack that 'forces were spinning up and ready to lunch' in Croatia and Spain. Although at the time, no one was to know exactly how long the attack was to ensue, no reply came and nothing was done at that time. Many others were killed because of the motionlessness of Mrs. Clinton and General Petraeus. One of the audience questions to Mr. Farrell was who he considered to be the most transparent president - his reply, knowing he would get a laugh, was President Nixon. He said that President Clinton lied, hid and got sued, President Bush got secretive because of 9/11, but they were also honest and just wouldn't give up certain documents because of the war on terror and President Obama talked a big game but in the end, has been the least transparent.

Mr. Farrell was also asked if Judicial Watch makes an effort to vet presidential candidates? He said no, that is not what their foundation does. They never endorse candidates, parties or purposes, they simply investigate and publish what they find.

Mr. Farrell has created a documentary called *The Sun City Cell*. He answers some groundbreaking questions, such as; How close did terrorists come to launching a major truck bomb attack on the city of Chicago? How has a major U.S. city become an operational base and staging area for a terror cell? And, How has corruption of high-ranking government officials and law enforcement officers left the U.S. vulnerable to a major terror strike?
